Schedule of Events

State Championship - Practice Day One

Thursday, February 25

Beginning of Practice – **Safelight**

During official practice, no boater or non-boater competitor may operate a boat unless that competitor has a documented boat owner's liability insurance of a minimum of \$300,000 (*per occurrence*) covering the boat being used.

End of Practice – **4:00 pm**

All contestants must be off the tournament waters.

State Championship - Final Practice Day

Friday, February 26

Beginning of Practice – **Safelight**

During official practice, no boater or non-boater competitor may operate a boat unless that competitor has a documented boat owner's liability insurance of a minimum of \$300,000 (*per occurrence*) covering the boat being used.

End of Practice – **3:00 pm**

All contestants must be off the tournament waters.

Registration - **3:00 pm thru 5:00 pm**

The registration will be held in the Grand Ballroom located at the Ramada. It is preferred that the entire team, attend registration including alternates. If the entire team is unable to attend registration, at least one team representative must register the team and verify the following required information.



- Verify team member names.
- Verify team member boater, non-boater, and alternate statuses.
- Verify team member cell numbers.
- Pay any and all outstanding club membership dues
- Required Documents (*required for each team member, including alternates*)
 - a. Texas and Mexico fishing licenses
 - b. Boat insurance for all boats being used in the tournament (*minimum of \$300,000 in liability per incident*)

Tournament Briefing and Pairing Dinner - 6:15 pm

The tournament briefing and pairing dinner will be held in the Grand Ballroom located at the Ramada. The dinner will be served at 6:30, and the briefing and pairing will follow dinner. There will be a cash bar, where tips are appreciated. **All contestants must be in attendance.**

(Due to National Park rules concerning the collection of monies within National Park borders, t-shirts, caps and raffle tickets will not be sold during each day's weigh-in. All sales will be made during registration and the briefing and pairing dinner. The raffle will still be held at the conclusion of the final day's weigh-in.)

State Championship - Competition Day One

Saturday, February 27

Launch - 7:00 am or safelight

The launch will be held at the Diablo East boat ramp. All contestants must be on the water and in their flights one hour prior to official launch time, no exceptions.

Weigh-In - 3:00 pm

The weigh-in will be held at the Diablo East boat ramp parking lot. The first flight is due in at 3:00 pm. Additional flights will be due in at 30-minute intervals after the first flight.



State Championship – Final Competition Day

Sunday, February 28

Launch - 7:00 am or safelight

The launch will be held at the Diablo East boat ramp. All contestants must be on the water and in their flights one hour prior to official launch time, no exceptions.

Weigh-In - 3:00 pm

The weigh-in will be held at the Diablo East boat ramp parking lot. The first flight is due in at 3:00 pm. Additional flights will be due in at 30-minute intervals after the first flight.

Question: Can I use my cell phone during the tournament as a GPS device to locate fish?

Answer: No, per the rules cell phones may only be used in case of an emergency.

Question: How many teams can my club send to the state championship?

Answer: See rule 2. "Participation and Eligibility" (ii)

Question: Can I use A-rigs (Alabama Rigs) During the tournament?

Answer: Yes.

Question: Is this tournament a pro/am B.A.S.S. Open style tournament?

Answer: Yes, this State Championship is an individual boater/non-boater "B.A.S.S. Open" style tournament where five (5) boaters and (5) non-boaters will earn berths to the Texas B.A.S.S. Nation State Team, which will compete at the B.A.S.S. Nation Central Regional.
