The insurance must be issued by a reputable insurer rated A or better by A.M. Best and Company. Policy must include international waters, or a separate policy for international waters must be obtained if I choose to fish international waters during applicable B.A.S.S. events. At B.A.S.S.'s request, I will provide satisfactory evidence of that insurance.
