### Own a Yamaha Outboard motor

- 115-425 HP
- Original Owner
- Purchased from a Yamaha dealer in the past 60 months
- Motor must be warranty registered

### Get Registered

- Register online at yamahapowerpay.com or send in one page registration form via email, fax, or U.S. mail
- Registered within 72 hours prior to fishing supported Power Pay tournament
- Receive official notification from Power Pay Program Office that your registration is complete





## HOW IT WORKS

### **PURCHASE - PARTICIPATE - PROFIT**

### Fish

- Fish a supported Power Pay tournament (List of 2020 Events / Payouts available at yamahapowerpay.com)
- Post the highest placing finish of those who are registered for the Program (Select tournament trails pay the top two highest finishes)
- Must finish in top 33% of final field
- Minimum field size of 50 boats

### Redeem

- Submit the official Yamaha Power Pay Award Form within 30-days of finish
- Upon verification / approval, contingency payment will be sent via U.S. mail
- Minimum of 8-10 weeks for review, processing, and distribution


