



TEXAS B.A.S.S. NATION Presents

2022 TEXAS B.A.S.S Nation State Championship

Note: The format for the 2022 State Championship has changed from previous years. This will no longer be a “draw” format tournament. Instead, anglers will fish as Club Teams (definition: three (3) boaters and three (3) non-boaters). Each Team is comprised of three (3) Pairs (definition: one (1) boater and one (1) non-boater). Members designated as Pairs will fish together throughout the State Championship Tournament. There will be NO switching of boaters or non-boaters within Pairs during the Tournament except in cases of verifiable emergencies. NOTE: For further information about the format changes in the 2022 State Championship Tournament, see the 2022 State Championship Rules at www.texasbass.org. 2022 State Championship rules will be posted no later than February 15, 2022.

Club Team entry fee: \$900.00

Pair entry fee: \$300.00 (\$170.00 for boaters and \$130.00 for non-boaters)

Big Bass Entry Fee: Included with Entry

Payout will be determined after the total number of entries is known.

Separate payout for club, boater, and non-boater.

Big Bass payout to the top two (2) boaters and two (2) top non-boaters for the two (2) largest legal bass for the tournament. Plaques awarded to Places 1-6 for each Club, Boater and Non-boater.

State Team anglers will receive paid entry fee to the B.A.S.S. Nation Central Regional Championship.

Texas B.A.S.S. Nation is excited to offer its membership another path to qualify for the BASSMASTER CLASSIC. State Championship Qualification is simple:

- (1) Compete within your Texas B.A.S.S. Nation Affiliated Club and earn an entry – either as a Boater or a non-boater. Clubs are allowed to enter up to 100% of their membership. The registration is processed by the Club President, and must maintain an equal number of both Boaters and Non-boaters.
- (2) Compete in your Texas B.A.S.S. Nation Affiliated Region and earn an entry as either a Boater or Non-boater. Regional Championship standings will be utilized to offer invitations to the State Team as both Boater and Co-Angler.

The Texas B.A.S.S. Nation Championship is an entry-fee based two-day event, where the top five (5) Boaters and five (5) Non-boaters will advance to the B.A.S.S. Nation Central Regional Tournament, as part of the Texas B.A.S.S. Nation State Team. The Central Regional Tournament will be held in 2022 somewhere in the Central U.S. The highest place finishers (1 Boater and 1 Co-Angler) from each State will then advance to the B.A.S.S. Nation National Championship.
